

#### C. Advocacy:

Since its inception in 1988 as state level network of NGOs and CBOs, it had conducted many advocacy campaigns like protection of biodiversity and promotion of sustainable development, implementation of PCPNDT Act for the prohibition of sex selection, before or after conception, and for regulation of pre- natal diagnostic techniques, advocacy for Inclusive Education to include children with disabilities in the main education system with empowerment of the teachers through training and during COVID pandemic for COVID vaccination. Latest campaigns were on the 'Changing Patterns of Climate and its impacts on water availability, biodiversity, soil quality, and flood and food security'.

Topsoil, the fertile upper layer of soil, is vital for food production, water filtration, climate regulation, and biodiversity. Its preservation is essential for a sustainable future. Protecting topsoil is crucial for sustaining life and ensuring a healthy planet.

# TOBACCO CONTROL PROJECT

As per the Global Adult Tobacco Survey, the prevalence of tobacco use was the highest in North Eastern States . Among them Tripura has the highest rates of tobacco use by the adults. Tripura was in the top of the list, with 64.5% of the people either smoking or using smokeless tobacco. This was an increase of 8.6% over the state's prevalence of 55.9% in 2009-10. The urgent action has to be taken to strengthen the National Tobacco Control Programmes (NTCP) Activities in Tripura as this was one of the high prevalence state. Although Government of Tripura has initiated the activities in all the 8(eight) districts of Tripura under NTCP but only 4 districts were functioning with full capacity. Special attention was needed to be given to the districts where the proper infrastructure was yet to develop. There was urgent need to strengthen the tobacco control process and capacity building of the functionaries both in NTCP and other stakeholder departments to accelerate reduction in tobacco use in the state.

As Tripura was one of the states with a significant tobacco burden, it required urgent and sustained action. Voluntary Health Association of Tripura (VHAT) has been working across all eight districts of the state through its Tobacco Control Project. The core objectives of the project included strengthening systems for tobacco control, building the capacity of law enforcement and government officials and engaging multiple stakeholders to foster a collaborative environment for comprehensive tobacco control and tobacco-free Tripura. In all of the activities under this project VHAT had work I close collaboration

with the State Tobacco Control Cell of Tripura.

#### **Objectives of the project:**

- Building capacity of key stakeholders for strengthening effective implementation of the National Tobacco Control Programme in Tripura
- Implementation of effective and evidence-based policies in line with MPOWER strategies for advancing tobacco control in the state
- To engage multi-stakeholders to create a collaborative environment for comprehensive tobacco control & tobacco free Tripura

## **Key activities during the financial year of 2024-25:**

- As part of ongoing efforts to strengthen tobacco control initiatives, district-level stakeholder sensitization workshops were successfully organized in two districts of Tripura. The first workshop was conducted in Khowai District on 28th October 2024 followed by the second in Unakoti District on 22nd January 2025. These workshops aimed to bring together key stakeholders to raise awareness, foster inter-departmental coordination, and reaffirm commitment toward the implementation of tobacco control measures at the grassroots level. Each event was graciously presided over by the Hon'ble Sabhadipati of the respective Zilla Parishads, whose leadership added significant value to the proceedings. The events witnessed active participation from officials representing various line departments, along with enthusiastic involvement from civil society organizations and youth clubs. Their collective presence underscored a shared resolve to address the challenges posed by tobacco use and to promote a healthier, tobacco-free community.
- > Sensitization events were organized to engage key grassroots stakeholders. On 18th March 2025, a session was held at the VHAT Office with NYK and NSS volunteers, along with youth club representatives, focusing on the importance of creating tobacco-free educational institutions and villages.

Another event was conducted on 26th March 2025 with ASHA and Anganwadi workers. This session was made possible with the active support of the district health authorities and the National Health Mission (NHM), Tripura. Both events aimed to equip community-level influencers with the knowledge and motivation needed to promote healthier, tobacco-free communities.

- A District-Level Coordination Committee (DLCC) meeting under the National Tobacco Control Programme (NTCP) for Gomati District was held under the chairmanship of the District Magistrate & Collector on 18th November 2024 in the Conference Hall, office of the DM & Collector, Udaipur, Gomati. This meeting was attended by the Superintendent of Police; Chief Medical Officer, Gomati Tripura; District Education Officer; District Nodal Officer (NTCP); District Information Officer; representatives of the SDMs of Udaipur, Amarpur, and Karbook; Principal of NS Mahavidyalaya; Principal of Gomati District Polytechnic College; Inspecting Officer of Drugs; Food Inspector; and other concerned officials.
- World No Tobacco Day 2024 was observed in four districts with the theme "Protecting children from tobacco industry interference". This theme highlighted the need to safeguard young people from the manipulative tactics and harmful influence of the tobacco industry.
- As part of a state-wide initiative to promote tobacco control through grassroots advocacy, district-level meetings were conducted with women Self-Help Group (SHG) leaders across all eight districts of Tripura. These activities were organized in collaboration with the district administrations and the Tripura Rural Livelihood Mission (TRLM), aiming to sensitize and empower SHG leaders to take an active role in creating tobacco-free communities. The advocacy meetings were held in West Tripura on 16th November 2024, in Dhalai and Gomati on 25th October 2024, in Unakoti on 13th November 2024, in North Tripura on 30th December 2024, in Khowai on 18th January 2025, South Tripura on 23<sup>rd</sup> December 2024 and in Sepahijala on 6th March 2025. These interactive sessions enabled women leaders to better understand the risks of tobacco use and equipped them with the knowledge and motivation to act as champions of change within their respective villages.

A district-level law enforcement training session on tobacco control was organized in North Tripura District on 30th September 2024. The training brought together Police Officials, local administrative personnel, and representatives from the Education Department, with the aim of strengthening interdepartmental coordination and effective enforcement of tobacco control laws at the ground level. The session was presided over by the Additional District Magistrate & Collector of North Tripura, whose presence underscored the administrative commitment to the cause. Among other dignitaries present were the Chief Medical Officer, District Education Officer, and the Additional Superintendent of Police, all of whom contributed valuable insights and reaffirmed their departments' support in building a tobacco-free environment.

- A state-level workshop on Tobacco-Free Educational Institutions (ToFEI) was successfully held on 28th January 2025, in collaboration with the Department of Secondary Education, Government of Tripura. The workshop aimed to promote the implementation of tobacco-free norms across schools and colleges in the state, fostering a healthier environment for students. The event was graced by the esteemed presence of the Vice Chancellor of the National Law University, Tripura, and the Director of Secondary Education, Government of Tripura. Their participation added significant value to the discussions, reinforcing the importance of institutional leadership and policy enforcement in creating tobacco-free campuses.
- As part of a collaborative effort to strengthen tobacco control in the state, initiatives had been undertaken to establish a coalition titled "Alliance for a Tobacco-Free Tripura." This alliance brings together a diverse group of stakeholders, including government officials, academic institutions, civil society organizations (CSOs). So far, two meetings have been successfully conducted with active participation from the members. A provisional committee has also been constituted, with Prof. (Dr.) Yogesh Pratap Singh, Hon'ble Vice Chancellor of the National Law University, Tripura, serving as its Chairperson.

## **Key achievements:**

- During the 2024 Parliamentary elections, a significant step was taken toward promoting public health through the issuance of notifications by the Returning Officers of both the East Tripura and West Tripura Parliamentary constituencies, designating all polling booths as "Tobacco-Free Zones." This initiative received strong support from both district administrations. Further reinforcing the effort, a similar notification was also issued by the Office of the Chief Electoral Officer, Tripura, which greatly boosted the momentum of the *Tobacco-Free Polling Booth* campaign.
- The Joint Mission Director of the National Health Mission, Tripura, issued a notification on 13th September 2024 regarding the implementation of the *Tobacco-Free Youth Campaign 2.2*. The campaign was conducted over a period of 60 days, commencing on 24th September 2024, and was implemented across the state. The primary objectives of the campaign were to intensify public awareness about the harmful effects of tobacco use, promote greater compliance with the *Tobacco-Free Educational Institutions (ToFEI)* guidelines, strengthen the enforcement of the *Cigarettes and Other Tobacco Products Act (COTPA), 2003* and the *Prohibition of Electronic Cigarettes Act (PECA), 2019*, and to advance the initiative for creating *Tobacco-Free Villages* in Tripura.
- A significant milestone under the Tobacco Control Project was the formal adoption of Article 5.3 of the WHO Framework Convention on Tobacco Control (FCTC) by the State of Tripura on 5th February 2025. In line with this commitment, a high-powered committee has been constituted under the chairmanship of the Secretary, Health Department, Government of Tripura, to monitor and address any interference by the tobacco industry in public health policy matters.

Article 5.3 of the WHO FCTC mandates that: "In setting and implementing their public health policies with respect to tobacco control, Parties shall act to protect these policies from commercial and other vested interests of the tobacco industry in accordance with national law." This step marks a proactive move by the state to safeguard public health policies from industry influence and reinforces Tripura's dedication to a tobacco-free future.

Voluntary Health Association of Tripura (VHAT) organized one workshop on "ONE HEALTH - Antibiotics Resistance" on 21st February 2025 at the Press Club, Agartala, Tripura. The event focused on the critical issue of antibiotic resistance and its impact on human health, agriculture, veterinary sciences, and fisheries. The workshop brought together dignitaries, experts, and participants from various fields to discuss challenges and solutions related to antibiotic use. Totally 60 persons from Nursing Institutte, NGOs, Youth Club Volunteers, Agriculture College, Members of Women SHGs and Veterinary Institute participated in this workshop.

The welcome speech was delivered by Dr. Sreelekha Ray, President, VHAT, who emphasized the importance of addressing antibiotic resistance (ABR) as a global health concern and the need for a multidisciplinary approach. She highlighted how antibiotic resistance not only threatens public health but also affects food security and economic stability, making immediate need of intervention.

The technical session was chaired by Dr. R.R. Chhetree, Principal, Regional Institute of Pharmaceutical Science and Technology, Agartala. The session involved discussion on the topic "Rationality of Antibiotic Use."

First Speaker: Dr. Parimal Roy, Professor, College of Veterinary Sciences & Animal Husbandry discussed on the topic "Use of Antibiotics in Animal Husbandry Sector and its consequences". Dr. Parimal Roy highlighted the followings: -

- Rampant use of antibiotics in livestock farming would have negative impact on food safety and public health.
- Antibiotic residues found in dairy and meat products will develop antibiotic-resistant bacteria, which can be
- Policymakers must implement strict regulations on antibiotic use in animal husbandry.
- He further highlighted the emergence of zoonotic diseases linked to antibiotic-resistant bacteria, stressing the need for responsible usage.

Second Speaker: Dr. Himadri Saha, Assistant Professor, College of Fisheries, Lembucherra, West Tripura had a brief discussion on "Use of Antibiotics in Fisheries & Challenges."

- Wide use of antibiotics in aquaculture to prevent and treat bacterial infections in fish is harmful.
- There are risks associated with antibiotic residues in water bodies which can lead to ecological imbalance and the proliferation of antibiotic-resistant pathogens.
- Need to adopt probiotic treatments and biosecurity measures to reduce dependence on antibiotics in fisheries.
- Antibiotic contamination in water systems could lead to irreversible environmental damage.

The session concluded with an interactive discussion with participants, where key concerns and possible solutions were deliberated by the experts of the technical session. Page-14

- Identification of Elderly Persons in- need of Nutritional support

In the camp 86 elderly persons were treated after the check up. And ten senior persons, who were found with under nutrition, received the nutritional kits.

One awareness generation session was conducted with the camp beneficiaries on 'how to take self care of the health of a senior person, nutritional requirement of them, adequate rest, sleep and exercise to keep them physically & mentally healthy '.

# RATANMANI VIDYALAY: A RESIDENTIAL PRIMARY SCHOOL FOR TRIBAL CHILDREN

VHAT started a non-formal education centre in April 1994 with a few village tribal children & developed a condensed course to complete the study of Class 1 to Class V within three years. In the year 2000, this centre got the recognition from the state education department as junior basic school by the name "Ratanmani Vidyalay" with the aim to promote quality primary education of the tribal children living in this remote hilly areas of Rupaichari block under South Tripura district. As on March 2025 Ratanmani Vidyalay completed thirty one (31) years of its existence and achieved the status of quality primary education centre for the poor tribal children in the area.

## **Students – category:**

In 2024-2025, three hundred six (306) children from various block of South Tripura & Gomati district under the Tribal Area Autonomous District Council admitted in Ratanmani Vidyalaya and 289 children were accommodated in the school hostel. The Open Shelters provided an enriched platform for learning that empowered the children not only to get education but also to develop their self-confidence and self-esteem. It provided services such as education, nutrition, knowledge of computer. Life Skill Education and vocational training.

The children were guided by House Parents, In-charge, Para-medical staff and two Social Workers. They were supported by extra coaching teachers. Apart from educational support, the children were provided with computer lab to enhance their computer knowledge in extracurricular activities. Life Skill Education training also organized for the children based on their appropriate age. Children observed all the national days with cultural activities.

# ANWESHA CHILDREN HOME FOR GIRLS

Anwesha Children Home for Girls a registered CCI under the J.J. Act, Ministry of Women & Child Development for 50 girl children. It provides long term shelter for orphaned and underprivileged girls till completion of 18 years of age. The mission of this CCI was to rescue and protect children from the trauma of physical and sexual abuse, extreme neglect, being abandoned and being a victim or witness of domestic violence.

Children were provided shelter, nutrition, education, basic computer knowledge, recreation, medical support and life skill education. To provide a variety of experiences to children, Anwesha Home had undertaken activities like free and structured conversation, rhymes, songs, story-telling, story making, music and movement, dramatization, indoor play activities with blocks, beads, puzzles, clay modeling, outdoor games and outdoor activities including free play running, jumping, hopping, balancing, sand play and gardening. The wall magazine "Anweshon" was pulished on quarterly basis the children. All the stories, poems and drawings were written by the children by their own efforts for this wall magazine.

## Children were involved in following Key Developmental Activities:

- Education all children were enrolled in three government schools where they were regularly attending classes.
- Participating in some household chores which helped children learn about what they need to do to care for themselves, a home and a family.
- Counseling & Emotional Well-being Peer counseling in individual situations.
- Training & Capacity building –to encourage the leadership to evaluate their abilities to perform in a complex environment.
- Life Skill training on decision-making, creative thinking, interpersonal relationship skills, self-awareness building skills, empathy and coping with stress and emotions.
- Co-curricular activities-dance, yoga, meditation, painting competitions as well as other recreational activities
- Pre-Vocational Training in stitching and handicrafts, kitchen garden and animal rearing
- Computer Education /digital literacy
- •Engaging children in meaningful activities was the pivotal part of the program e.g preparing wall magazine, psychosocial activities that improved personal and social skills, alternative learning, physical activities, games and fun!

**Medical Care and Services provided:** Individual medical file was maintained for all the children. Following were the medical services provided to the children.

- ❖ Monthly height-weight and BMI record keeping.
- Immunization as per government schedule
- Monthly Health Check-up and treatment.
- ❖ Annual Dental and ENT check-up. Vision Test. Emergency Medical care.
- Counseling & psychosocial interventions as per need.

# UNMESH CHILDREN HOME FOR BOYS

Unmesh Children Home for Boys is situated in East Gokulnagar, Sepahijala District. The home was started from September 2018 It was registered under Juvenile Justices Act-2015, under Ministry of Women and Child Development on 7<sup>th</sup> June,2019. During the 2024-2025, 50 children were staying on an average in the home who came with the order from CWC of different districts of Tripura. All the Children were engaged in different co-curricular activities like yoga, sports, gardening, music, drama and drawing.

Class wise number of the children: Anganwadi Centre- 1, Class-1: 4, Class-II: 3, Class-III: 9, Class-IV:

7, Class-V: 1, Class-VI: 10, Class-VII: 3, Class-VIII: 7, Class-IX: 3, Class-X: 1, Class XI-1

**Regular monthly health check-up and treatment** to all the children were provided by Medical team of Bishalgarh Hospital. One residential GNM (Nurse) was taking care of the health of the children.

**Home visit & reintegration :** This year, **17 children** were reintegrated to the families or extended families after the social investigation of the family situation and counseling of both children and family members. The SIRs(social investigation reports) and counseling were done by the Case Worker and the Counselor of the CCI . Shifting and reintegration was done with the orders from the Child Welfare Committees.

Unlike other CCIs, the targeted children for Manorama Home are the Children of 5-18 year age group of the following categories-

Orphaned Children. □ Victims of violence/abuse.

Abandoned Children \(\partial POCSO\) victims \(\partial \text{HIV}\) \(\Delta\) LDS victim

Our current number of inmates had reached 44 vibrant young minds, all actively pursuing education in local government schools as follows:-



# FAMILY STRENGTHENING-FAMILY BASED ALTERNATIVE CARE (FS-FBAC)

This initiative was supported by Miracle Foundation India. Project activities were being implemented as per the UN Guidelines for Alternative Care of Children, where it stated that: "Family is the fundamental group of society and the natural environment for the growth, well-being and protection of children, and efforts should be primarily directed to enabling the child to remain in or return to the care of his/her parents, or when appropriate, other close family members."

The project was still in pilot mode. Selected project areas were- Mohanpur, Bamutia, and Jirania block in West Tripura district & Bishalgarh and Boxanagar block in Sepahijala district. Within each block, three vulnerable panchayats were identified as hotspots, making a total of 15 panchayats across the two districts.

A vulnerability assessment survey was conducted in all selected panchayats, which revealed 175 families living in highly vulnerable conditions, requiring immediate and sustained intervention.

## **Key interventions included:**

- Career counseling and life-skills guidance for young adults to support informed and empowered future choices.
- Facilitation of Village-Level Child Protection Committees (VLCPCs) to enhance local child protection mechanisms.
- Strengthening of Bal Panchayats to ensure children's voices are represented in community matters.
- Promotion of Child-Friendly Eco Villages to create safe, inclusive, and nurturing environments for children.
- Community awareness and sensitization programmes on child rights, child protection, and collective responsibility.

Through these multi-dimensional efforts, the initiative has been instrumental in fostering safer, more supportive communities for children and youth.

#### **Project Goals:**

- Reintegration of Children from CCIs: From April 2024 to March 2025, 29 children reintegrate from CCI's to family settings.
- Community Prevention & Strengthening: Addressing vulnerabilities at the community level, empowering families to provide sustainable care for their children.

# Approach/strategy:

- i)Home visits and family crisis intervention: regular visits to the homes of children placed in our care(CCIs) to assess family dynamics and address any crises or challenges they may be facing. Through working closely with families to resolve issues and our aim was to create a conductive environment for child's return.
- **ii)** Social investigation Reports: through investigations to understand the root causes of family separation and identify the necessary interventions to facilitate reintegration, the report was prepared.
- **iii) Five well-being domains:** We focused on five key domains of family well-being: Economic stability, access to education and health care, social support networks, safe and stable housing and emotional well-being.
- iv) Continuous Follow- Up and Family Support: Our commitment to reintegration extends beyond the initialization process.
- v) Mental Health focus: this included counseling, therapy and psychosocial support to promote healing, resilience and positive mental health outcomes.
- **vi)** Community Awareness Program: We committed to raising awareness within communities about the importance of family-based care for children, through workshops, seminars and outreach initiatives. Another aim was to educate people in the community about the benefits of various government schemes for providing benefits to the children.

- vii)Prevention of Institutionalization: It was aimed to keep children within their families or place them in alternative family-based care arrangements.
- **viii) Gate keeping:** By identifying vulnerable families early on, we tried to provide them with necessary support and resources to prevent the unnecessary placement of children in institutions.
- **ix) Awareness program with Adolescents:** We conduct targeted awareness programs with adolescents to address issues such as Child Marriage and other forms of exploitation as per the Protection of Children from Sexual Offences (POCSO) Act.
- **x) Reporting Mechanisms:** We facilitated reporting mechanisms for community members to report cases of child abuse, neglect or exploitation through help lines, online platforms, and community-based reporting systems.
- **xi)** Child Participation: Children were involved in decision -making processes that affect their lives. Attempts were to empower children to express their views, preferences and concerns, ensuring that their voices were heard and respected.

#### **Challenges Faced:**

- **Resource Limitations**: Despite successes, limited funding impacted our ability to expand family-strengthening outreach.
- **Stigma Around Foster Care**: We faced some cultural barriers to acceptance of foster care, addressed through targeted community education sessions.

**Conclusion:** In Anwesha Home, Unmesh & Manorama Shishu Niketan, run by VHAT, our comprehensive approach to child reintegration encompassed proactive family engagement, targeted interventions and ongoing support to ensure that children were reintegrated into safe, loving and stable family environment. By prioritizing family well-being and mental health, we strived to facilitate successful and sustainable reunifications that enable to children to thrive within their families. VHAT, through this FBAC project could provide livelihood support to two families for animal rearing and fast food business. Eight parents got psychological counseling and parenting skill training. !n 2024-25 we could reintegrate **29 children** from Anwesha CCI run by VHAT.

# VHAT -STATE NODAL AGENCY CENTRE TRIPURA UNDER THE NATIONAL TRUST

VHAT is a registered organization under the National Trust a statutory body of the Ministry of Social Justice and Empowerment, Government of India (Under section 12 (4) of the Act). It has been working as the State Nodal Agency (SNAC) of Tripura, under National Trust since January 01,2021 and was implementing various activities of the National Trust for welfare of the person with Autism, Cerebral Palsy, Mental Retardation and Multiple Disabilities in this state. VHAT is the member of Local Level Committee (LLC) in three districts of Tripura viz. South Tripura District, North Tripura District and Unokoti District.

# As per National Trust norms, VHAT implemented following activities in 2024-25:

- ♠ In 2024-2025, VHAT enrolled 39 (Thirty-nine) new beneficiaries for Niramaya Health Insurance Scheme and did renewal of the Health Cards for 27 (Twenty-seven) beneficiaries in this scheme.
- ♠10th to 20th May 2024, &12th to 22nd Feb 2025, Voluntary Health Association of Tripura organized "BADTHE KADAM" a community awareness activity regarding the schemes of National Trust for the welfare of PWDs (autism, intellectual disability, cerebral palsy, and multiple disability) through distribution of 5000 number printed leaflets and posters along with small group discussion.
- ♦On November 27th, 2024, under "BADTHE KADAM" a drawing competition was organized for children with disabilities, fostering creativity and inclusivity. 17 young participants showcased their artistic talents, supported enthusiastically by their parents and other attendees.
- ♠On 29th September,2024 an event was organized by the VHAT to mark World Alzheimer's Day. The event focused on spreading awareness about the challenges posed by Alzheimer's disease and the importance of early detection and care for the elderly affected by it.

♠ World Down Syndrome Day was observed on 21st March 2025 through one-day workshop focusing on the

theme "Improve Our Support System.", for creation of awareness among the community.

- ♦VHAT actively participated in the two-days Khelo Tripura Para Games- 2024 for creating awareness regarding various schemes of National Trust, focusing on Niramaya Health Insurance and Legal Guardianship. The event was organized on the 18th and 19th of December at Swami Vivekananda Maidan in Agartala by Social Welfare and Social Education Dept. Govt of Tripura.
- ♠ On 12th March-2025 VHAT participated in a one-day Purple Fair-2025, organized by Composite Regional Centre of Tripura under NILD, Kolkata with the support from Ministry of Social Justice and Empowerment, Govt. of Tripura. Our stall in the event was for spreading the massage regarding Niramaya Health Insurance and Legal Guardianship to improve positive participation of the community.
- ♠ A special workshop focused on the welfare of Divyangjan (persons with disabilities) was organized on 24th January, 2025 at the Conference Hall of the Education Department in Gomati District.

- ♦ VHAT as the SNAC observed World Disability Day on 3rd December 2024 in collaboration with the District Disability Rehabilitation Centre (DDRC) of West Tripura District.
- ♠12th Feb to 22nd Feb2025, we organized "BADTHE KADAM" a community awareness activity regarding the schemes of National Trust for the welfare of PWDs through distribution of 2500 printed leaflets and posters. One workshop for creating awareness among school teachers was organized in collaboration with Samagra Siksha Aviyan within this period.
- ♠Consultation Program on RPwD act,2016 Organized by Voluntary Health Association of Tripura in collaboration with All Tripura Blind Association on 16th March 25 at the Conference Hall of CRC Narshingarh, Agartala with 40 participants present in the event.
- ♦ Voluntary Health Association of Tripura is a Local Level Committee member for issuing Legal Guardianship under the chairmanship of District Magistrate and Collector of North, South and Unakoti District of Tripura. Under the Chairmanship of DM & Collector total 02 (two) Legal Guardianship Certificates issued for the benefit of the PwDs.

# SHANTINEER-HALF WAY HOME(HWH)

VHAT has been running this home with support from the Social Welfare & Social Education Department under Government of Tripura. This shelter home was for the welfare & rehabilitation of persons living with mental illness (Schizophrenia )who have been cured, who do not need further hospitalization, who are homeless & who are not accepted by their families or guardians and are in need of shelter, care and protection. To meet this objective, the Govt. of Tripura has established 'SHANTINEER'—a Half Way Home at Narsingarh, West Tripura wherein 25 female and 25 male cured mental patients can be accommodated .

VHAT could initiate this project in October 2023 with 25 female inmates sent by the Modern Psychiatric Hospital, Narsingarh. In the year 2024-25, 25 female and 25 male inmates were staying in Half Way Home.

## **Services provided to the inmates:**

- 14 fulltime staff were engaged for the HWH
- Food: Breakfast, Lunch & Dinner and two times tea & snacks as per the diet chart approved by MPH.
- All necessary warm clothes & regular dresses were given
- Regular Health Check-up were done for all the inmates by the Doctors of Modern Psychiatric Hospital (MPH). Two fulltime residential Nurses taking care of their hygiene, giving them medicines & looking after whether they were taking food Properly. The MPH provided the list of medicines being administered to the inmates during handing over of the inmates from MPH to the SHANTINEER Half Way Home
- In case of relapse of symptoms, immediately they were shifted to MPH until their symptoms subsided.
- Repatriation/ Integration into family: On regular basis, our staff did home visits, discussed with the family members for taking back them in their original families. We also communicated with local leaders, panchayat Members and religious leaders. Out of them 12 (Female-10, Male -02) inmates were reintegrated to their family within last one year. We would continue the reintegration process as these cured mentally ill persons have the right to live with the families.
- The MPH was the inspecting authority for the SHANTINEER Half Way Home

# INDUS TOWERS SCHOLARSHIPS FOR STUDENTS WITH DISABILITIES

Since 2016, VHAT has been collaborating in various activities with Shishu Sarothi, an organization based in Guwahati, dedicated to early intervention and rehabilitation, education, advocacy, awareness, and the protection of rights for children and individuals with disabilities in North-East India. In relation to this we have been actively involved in implementing a Scholarship Program, aiming to empower students with disabilities to pursue higher education. Our goal was to counteract the declining trend and significant drop in the number of students with disabilities in higher education while fostering employment opportunities and the inclusion of Persons with Disabilities in the mainstream.

From Tripura, 51 students have already benefited from the scholarship support in pursuing their higher education, many of them securing jobs and leading a life of dignity and financial independence. In 2023-24, eleven (11) students/scholars were selected from different parts of Tripura for scholarship. This year Shishu Sarothi wanted to take feedback from those students regarding the improvement of their works with the support from Indus Tower Scholarship.

Accordingly on 5<sup>th</sup> February 2025 ,one Focus Group Discussion (FGD) was conducted with scholars of the Indus Towers Scholarship Program at VHAT Training Hall to understand their experiences, challenges, and recommendations for improving the program. The discussion aimed to assess the impact of the scholarship on their academic and professional journeys and explore ways to enhance support for future scholars. 07scholars participated in this Focus Group Discussion and all the scholars have completed higher education successfully with the financial support of Indus Towers Scholarship Program. The program was well thought-out by Mr. Saurav Chakraborty, ShishuSarothi ,Guwahati and Mr. Jyotirmoy Majumder , VHAT, Agartala.

Providing equal opportunities for persons with disabilities leads to their full participation in society, contributing to economic and social development while upholding human rights. This includes ensuring access to education, employment, healthcare, and other essential services, alongside addressing specific needs and removing barriers to participation. Ultimately, inclusion empowers individuals with disabilities to reach their full potential and contribute to a more just and equitable society.

# WORKSHOP ON RIGHTS OF PERSONS WITH DISABILITIES (RPWD) ACT 2016

Workshop on the **Rights of Persons with Disabilities (RPWD) Act 2016** was conducted on the 18th of March, 2025. This workshop was organized by **Voluntary Health Association of Tripura** in collaboration with the **All Tripura Blind Association** to raise awareness and encourage discussions around the provisions of the RPWD Act, particularly for the blind and visually impaired community. The event took place in Conference Hall of CRC Narsingarh. Dr. A K Kushwasa, Admin officer CRC inaugurated the workshop.

The event aimed to facilitate an in-depth understanding of the Act's provisions and discuss how its implementation impacts the rights and opportunities for persons with disabilities (PWDs) in Tripura.

- To raise awareness about the RPWD Act -2016 and NT Act-1999 among the blind and visually impaired community.
- To foster discussions on challenges faced by the PWDs in Tripura.
- To understand the role of local authorities and organizations in the implementation of the RPWD Act 2016
- To ensure better compliance and accessibility in public spaces and workplaces.
- To empower participants with knowledge of the Act's provisions, including accessibility, education, employment, and social security.

47persons actively participated from the various group of stakeholders, including:

- Representatives from the All Tripura Blind Association.
- Government officials from the Composite Regional Centre
- Experts and legal professionals in disability rights.
- Members of the **blind and visually impaired community**.
- NGOs working with persons with disabilities (PWDs).
- General public and concerned citizens.

Resource Persons were-. Dr. Litan Bhowmik, Councilor cum legal expert, Mr.Joydeep Bhusan, SNAC Cordinator,

Adv.HaridasDatta, Legal consultant & Mr. Jyotirmoy Majumder, Coordinator of VHAT.

During open discussion with the Participants various points came up for more accessibility and better implementation of the ACT. Therefore, few recommendations were made:

- Strengthening the implementation and monitoring of the RPWD Act at local and state levels.
- Setting up a state-level task force for disability rights that can oversee the effective implementation of the Act

- **Training government staff** in handling disability-related issues, including providing better services for persons with disabilities.
- Conducting **regular workshops and awareness programs** for the general public about the rights of persons with disabilities.

The workshop concluded with a speech by the Mr. Jyotirmoy Majumder, Coordinator VHAT, who emphasized the importance of collaborative efforts in ensuring that the RPWD Act's provisions translate into real-life improvements for persons with disabilities.

# DISTRIBUTION OF SMART CANES FOR PERSONS WITH VISUAL IMPAIRMENT

On June 21, 2024, Voluntary Health Association of Tripura organized a Saarthi Smart Canes distribution event among the persons with visual impairment in collaboration with Blind People's Association and Torchit, Gujrat. These appliances (Saarthi Smart Canes) were supported by IRCTC for the visually impaired individuals. It was successfully conducted at the Conference Hall of IEPVD in Narsingarh, West Tripura District. The event was graced by distinguished guests including the Chief Guest Mr. Haridullal Acharjee, Zilla Sabadhipati, West Tripura District, Honourable Guest Mr. Achintam Kilikdar, Deputy Commissioner, PWD, SW & SE Department, and Special GuestsMr. Dilip Raj, Station Officer, IRCTC (Indian Railway), Dr. Sreelekha Ray, President of VHAT, Mrs. Krishna Ray Goswami, Principal, IEPVD girls, Mr. Prem Katar, Communication Officer, Torchit, Gujrat, Mr. Adnam Shek, Programme officer, BPA, Gujrat.

The event started with an opening address by Dr.Sreelekha Ray, President, VHAT, highlighting the importance of these assistive devices and appealing to all to use the device during their movement for safety.

Mr.Achintam Kilikdar, Deputy Commissioner, PWD, emphasized this distribution program and categorical success, thanks to the collaborative efforts of all involved parties and the generous support of sponsorors. He hoped that the smart canes would make a lasting positive impact on the lives of the visually impaired community.

Mr.Prem Katar, Communication officer, Torchit, Gujrat, was significant in assisting technology in improving the lives of the visually impaired. He also details the operating system of the Smart Canes and benefits of smart canes. He also mentioned that the smart canes are designed to enhance mobility and independence for visually impaired individuals, incorporating modern technology to aid navigation and obstacle detection

The distribution process was meticulously organized, ensuring each recipient received proper guidance on using the smart canes effectively. During the program, 110 Persons with Visual Impairment received these assistive devices. The distribution of 110 smart canes represents a significant step towards empowering visually impaired individuals of our state. ### JAN SHIKSHAN SANSTHAN DHALAI

**Background**: Jan Shikshan Sansthan is one of the important scheme under the Ministry of Skill Development and Entrepreneurship; Government of India. Voluntary Health Association of Tripura (VHAT) has been implementing this scheme in Dhalai district of Tripura as JSS Dhalai since October 2021. JSS Dhalai covered entire Dhalai District and providing vocational skill training in non-formal mode reaching to the unreached areas in the age group of 15-45 years. The priority groups are women, SC, ST, Minorities and other backward sections of the society. We worked at the door step of the beneficiaries with a minimum infrastructure and resources through forming and mobilizingSelf Help Groups (SHGs), loan mobilization and establishing linkages with mainstream markets for sustainable livelihood generation.

#### Physical Progress in the year 2024-25:

The courses offered in the JSS were a blend of technical and employability skills. This enabled the beneficiaries in learning the right set of skills to be utilized for gainful self/wage employment. The courses were as follows:-

#### **Others Activities:**

Celebrated events were-World Health Day, Labor Day, International Yoga Day, World Skill Day, Har Ghar Tiranga, Independence Day, Swachaata Hi Seva, Gandhi Jayanti.

#### **Capacity building Workshop:**

As per the suggestions of the Ministry, JSS Dhalai has participated in a capacity-building workshop for Jan Shikshan Sansthan and also organized a capacity-building program for resource persons (Trainer) at Voluntary Health Association of Tripura, Agartala Office.

#### **Livelihood Activities:**

For the FY 2024-2025, we could form 40 SHGs , 48 pass out trainees were registered in Udyam Registration Portal for loan benefits and enterprise development. We have also mobilized loan up to 14 trainees with linkage to the bank.

#### PMVK:

J SS Dhalai has implemented PM Vishwakarma skill training on two trades i.e. Tailor (Darzi) and Assistant Hair Dresser(Barber Naai). The total target given for each trade is 120 and we have trained and certified 175 candidates, 19 trained for Barber Naai and 156 trained for Tailor Darzi.

# INTEGRATED TRIBAL DEVELOPMENT PROJECT (NORTH & KHOWAI DISTRICT)

In the year 2024-2025, Voluntary Health Association of Tripura (VHAT), with support from the National Bank for Agriculture and Rural Development (NABARD), Tripura Regional Office, was implementing the **Integrated Tribal Development Project (ITDP) Laljuri Block of North Tripura District** and **Kalyanpur Block of Khowai District**, with the primary objective of improving the socio-economic conditions of tribal families, while addressing the ecological concerns of the selected areas.

#### In Laljuri Block the project activities started in 2018-19:

#### **Project Coverage:**

- Villages Covered: 6 ADC villages ,Target Families: 300
- Area Covered: 300 acres

#### **Major Components Implemented:**

- 1. Horticultural Orchard Development (WADI)-Plantation support provided: 40 mango, 20 lemon, and 200 pineapple plants per beneficiary family for orchard development under the WADI model.
- 2. Health Camps (General / Special Eye & RCH) 27 health camps were organized across the project villages, covering general health checkups, eye care ,reproductive and child health (RCH).
- 3. Women Development Initiatives
  - 300 pressure cookers were distributed—one per family—to promote health and safety in cooking.
  - 15 poultry chicks per family were provided to promote backyard poultry farming as an additional income source.
- 4. Trainings provided:- To promote sustainable livelihoods and enhance local skills, following trainings were conducted:
  - 1. Orchard Development: 7 trainings
  - 2. Mushroom Cultivation: 6 Trainings
  - 3. Backyard Poultry Management: 10 Trainings
- 5. Water Source Development
  - 180 individual farm ponds/tanks developed with water lifting facilities.
  - 120 cluster-based water reservoirs were also established for community benefit.
- 6. Awareness events:
- ♦15 Legal Awareness Campaigns were conducted covering legal rights, gender sensitization, health, and Nutrition.
- ♠ 9 Digital Financial Literacy Awareness Program (dFLAP) organized, covering:
- ♠ PMJJBY, PBSBY, Jan Suraksha Yojana, APY, KCC, Mudra loans, ATM usage, and digital/less-cash transaction concepts.
- ♠Anti-Drug and Anti-Tobacco campaigns were also organized from the first year onwards.

#### In Kalyanpur Block under Khowai District, the project activities started in 2024-25:

#### **Project Coverage:**

The project aims to promote financial capability of 300 targeted families across two ADC villages and one Gram Panchayat through sustainable livelihood models tailored to the local context.

#### **Key Intervention Models followed in implemention:**

1. Horticulture Plantation Model – Benefiting **70 households** aimed to enhance green cover and generate sustainable long-term income through the cultivation of high-value horticultural crops (Mango, Lemon, Pine apple and border plan Moringa and as intercropping Ginger & Turmeric)

- 2. Integrated Fish Farming Model Engaging 60 households, this approach was to promote efficient resource utilization by combining aquaculture with complementary agricultural activities.
- 3. Integrated Pig Farming Model Targeting 170 households, this model was to support improved livestock management, income generation, and nutritional security.

#### **Major Components Implemented:**

- 1. Horticulture, Soil Management & Water Resource Development
  - Land clearing and preparation completed for WADI establishment.
  - Plantation support: **60 mangoes**, **20 lemon**, **200 pineapple**, and **20 moringa (as border plants)** per beneficiary.
  - Totally **70 families** benefited under this intervention.
- 2. Fishery Farming with Duckery & Orchard Development
  - 60 ducklings distributed to each of the **60 beneficiaries**, along with lemon plantation in pond areas.
  - Beekeeping training conducted and **bee boxes** distributed to **60 households** to support apiculture as an income-generating activity for women.
- 3. Integrated Piggery Farming with Orchard Development
  - 170 families supported with 2 piglets each, along with:
    - Pig shed construction support Feeding assistance
    - o Orchard development: 50 mango and 20 lemon plants per beneficiary under the integrated model.
- 4. Health Awareness and Sanitation
  - 18 Focus Group Discussions (FGDs) on health and hygiene (2 FGDs per village per year for 3 years).
  - **18 general health camps** organized (2 per village per year), with emphasis on general health and malaria prevention.
  - 9 Eye/RCH camps planned over 3 years (1 camp per village per year).
- 5. Women Development Initiatives
  - 10 awareness sessions on menstrual hygiene for adolescent girls in collaboration with local education and health authorities, targeting 500 participants. Sanitary napkins were distributed during these sessions.
  - **300 families** supported for **organic kitchen garden promotion**, organized in 10 batches. This intervention ensures access to green, organic vegetables and promotes better health and nutrition, particularly for women and children.
- 6. Nutri Garden Development
  - Promoted to ensure household-level nutritional security through self-grown fruits and vegetables.
- 7. Training & Capacity Building
  - Trainings for PIA staff on project implementation and monitoring- 1 Training has been completed.
  - Orchard development trainings for farmers- 1 training completed
  - Fish cultivation trainings for relevant beneficiaries- 1 training completed
  - Pig rearing trainings to enhance livestock management practices- 1 training completed.

# LIVELIHOOD PROMOTION THROUGH PIG REARING AND INITIATIVES TOWARDS WOMEN EMPOWERMENT

#### **Initiation:**

Pig rearing is one of the important livelihood activities of the indigenous people of Tripura. This project aims for the scientific pig rearing, engaging the women SHG members towards enhancing the livelihood in a cluster approach manner. With support from **Azim Premji Foundation (APF),** VHAT initiated the project in December 2024.

The project was started in 2 (two) Village Councils i:e- Shivnagar VC and Ujan Machmara VC. 400 households (HH) were targeted ,who were mainly from the Tribal Community in Laljuri Block of North Tripura district. The prime objective of the project was to improve the socio-economic condition of the women in the tribal community.


#### Major Components under the project were: -

- Pig farming with technical support, followed by marketing linkages.
- Capacity building of women on preventive health care, especially on menstrual hygiene.
- Organizing special health camps for women.
- EDP training for women, supporting the women SHGs in book keeping,
- To provide trained CRP (Pashu Nurse) from the villages to support the pig rearing activities.

#### **Cumulative progress done till March 2025:**

- ✓ Base-line Survey of more than 500 House Holds(HHs) & selection of 200 beneficiaries for 1<sup>st</sup> phase.
- ✓ Staff Orientation including the Pashu Nurse.
- ✓ Formation of 20 PGs & trained them in 5 Batches on Pig Rearing & Management
- ✓ Formation of CRC committee including establishment of CRC:
  - ❖ Assigned 3 nos. of Pashu Nurse to support the beneficiaries on regular basis.
  - ❖ 5 Batches Training done on Pig Rearing & Management including the awareness on social security schemes covering 200 beneficiaries out of 400.
  - ❖ 80 nos. of pig shed construction completed.
  - ❖ Total 80 nos. piglets distributed to 40 no.families under the project. Total 400 HHs to be covered in three years.
  - ❖ Good quality Pig feed supplied to 40 HHs. One Community Resource Centre (CRCs) established and one committee has been formed for managing Community Resource Centre (CRCs) for regular support to the pig farmers, providing Pig Feed & marketing support to the beneficiaries.

# ENTREPRENEURSHIP DEVELOPMENT PROGRAMME UNDER SANKALP SCHEME

#### **Background:**

The "Skill Acquisition and Knowledge Awareness for Livelihood Promotion" (SANKALP) scheme was launched by the Directorate of Skill Development and entrusted to CognoLabs for implementation through NI-MSME. We have signed a Memorandum of Understanding (MoU) with CognoLabs to implement this scheme in Tripura, targeting the training of 500 candidates across 10 batches.

Under this initiative, **certificates would be issued by NI-MSME** upon the successful completion of the trainings. The training period for the project was from **September 2024 to January 2025.** 

#### Area coverage under this Training:

The project was implemented in 5 (Five) locations under 4 (Four) Districts- Agartala in West Tripura, Udaipur & Amarpur in Gomati District, Kalyanpur in Khowai District and Ambassa in Dhalai District.

#### **Objectives:**

- To address the issue of Enterprise promotion, capacity building of micro entrepreneurs.
- To engage the people in setting up of micro enterprise for livelihood development.
- To take initiatives for overcoming the challenges to established micro enterprise.
- ❖ To reduce the unemployment through enterprise promotion.

#### **Candidates Coverage through EDP Training:**

- ➤ In Agartala- 2 batches completed covering 100 candidates.
- ➤ At Ambassa-3 batches completed covering 150 candidates.
- ➤ 2 batches completed at Udaipur covering 100 candidates.
- ➤ 1 batch completed at Amarpur covering 50 candidates.
- At Kalyanpur 2 batches completed & trained 100 candidates.

#### **Outcome of this Training:**

Total 500 candidates trained under SANKALP scheme of Skill Development. Total 482 candidates assessed & pass-out among 500. Which shows that 96.4% success achieved. A number of 47 persons started processing of micro enterprise set-up. Another 15% candidates joined in the refreshing training of EDP through online mode provided by ECHO India & VHAT.

### ■ SHELTER HOUSES FOR URBAN HOMELESS

**Deendayal Antyodaya Yojana-National Urban Livelihoods Mission (DAY-NULM)** is a scheme under the aegis of the Ministry of Housing and Urban Affairs. NULM constructed few Shelter Houses for the vulnerable segments of the urban homeless like the dependent children, aged person, disabled, migrated students coming for competitive exam or interview and the patient party coming to town for medical purpose/treatment. Since January 2024, VHAT has been actively looking after the shelter houses in Agartala, Udaipur, Amarpur &Dharmanagar and making sure that all the necessities were available in these shelter houses.

To disseminate the information about the facilities in shelter houses, VHAT staffs did the outreach activities in several locations under the below Shelters:-

- 1. Radhanagar Shelter House, Agartala: Shelter house staff have visited Chandrapur, Nagerjala & Radhanagar bus stand, GB Bazar, Badharghat & Jogendranagar Railway Station. Organized meetings with vehicle drivers associations & the passengers for increasing the number of inmates. Also visited to the patient attendants or relatives of patients who were admitted in the GB Panth Hospital, IGM Hospital, Hapania Medical College & Hospital, and various Nursing Homes so that they can avail the facility of stay in the shelter house. In 2024-25 totally 1106 inmates got the staying facility in the shelter. We have visited various government offices like Police Stations, Clubs, Bazaar Committees, Bus Stands, and Railway Station to spread the messages. We have also fixed banners, distributed leaflets in public places to help people know about shelter's location and facilities.
- 2. **Pandit Deendayal Shelter House, Udaipur, Tepania:** Shelter house staff have visited key public locations such as Gomati District Hospital, Udaipur College, Rajarbag Bus Stand, Matabari, and Udaipur Railway Station. Meetings were organized with vehicle drivers and passengers to encourage more individuals in need to utilize the shelter facility. We also interacted with patient attendants and relatives of patients admitted at Gomati District Hospital and the Sub-Divisional Hospital, informing them about the availability of shelter facilities. During the financial year 2024–25, 596 individuals were provided with accommodation in the shelter.
- 3. **Dinadayal Shelter House, Amarpur:** We have visited the Amarpur Sub-Divisional Hospital, Nagerjala& Amarpur bus stand, Karbook Bazar, Amarpur College. Organized meeting with vehicle drivers & the passengers for increasing the number of inmates. Also visited to the patient attendant or relatives those patients were admitted in the Amarpur Sub-Divisional Hospital for their staying in the shelter. In the 2024-25, 60 persons got the staying facility in the shelter..
- 4. **Dharmanagar Shelter House:** We have visited the Dharmanagar ISBT, Rajbari bus stand, Dharmanagar Bazar & Railway Station, Dharmanagar Hospital. Organized meeting with vehicle drivers & the passengers for increasing the number of inmates. Also visited to the patient attendant or relatives those patients were admitted in the Dharmanagar Hospital & various Nursing Homes.

  In the 2024-25, 57 persons got the staying facility in the shelter..

Shelter house staffs have done flower gardening in front of the shelters for beautification & to make it attractive. Staffs were also doing organic farming inside the boundary & in the roof top of the shelters.

Providing shelter for homeless individuals is a multi-faceted effort involving government initiatives, non-profit organizations, and community involvement. Government programs like the Shelter for Urban Homeless (SUH) under DAY-NULM provide, all-weather shelters with basic amenities. Individuals can also contribute by donating to shelters, volunteering time, or offering direct assistance like food and clothing.

And on 7<sup>th</sup> March, 2025, at Panchayat Raj Training Institute (PRTI), Ambassa, Dhalai district of Tripura. Both the events brought together SHG members, individual women entrepreneurs, JSS women trainees (in case of Ambassa), and other women participants to celebrate women's empowerment and discuss opportunities for development. Total Participants in Agartala were 78 women & in Ambassa were 88 women & men.

Chief Guest in Agartala was Mr. Anil Kotmire, General Manager of NABARD, and Mr. Amit Das, DDM Dhalai District in Ambassa. Mr. Anil Kotmire delivered the welcome speech, extending warm greetings to all attendees. He emphasized the significance of celebrating International Women's Day and acknowledged the valuable contributions of women to society.

Ms.Megha Jain, ADM West Triputa, shared an inspiring story of a woman entrepreneur from North Tripura who started a small business with minimal investment and, through perseverance and support from bank loans, successfully expanded her enterprise. She encouraged women to strive for financial independence and maintain high standards in their work.

### ■ MAPPING OF MICRO, SMALL, MEDIUM ENTERPRISES (MSME)

Voluntary Health Association of Tripura (VHAT), with support from Cognolabs, Hyderabad, undertook a detailed survey *from January 2025-March 2025*, to assess the current state of MSMEs, skill training institutes, and the perspectives of high-ranking officials involved in the sector. The objective was to identify gaps, opportunities, and areas for strategic intervention that could drive sustainable economic growth in Tripura. Findings of the survey were stated below:

**1.** Mapping the MSME Sector— The survey covered eight districts of Tripura, aiming to assess and document the presence of MSMEs in each region, their production, skill required in present and future.

Targeted MSMEs: 674, achieved MSMEs: 662. With an achievement rate of **98.22%**, the mapping exercise successfully provided a near-complete picture of MSME activity in the state.

#### 2. Evaluating Skill Development Institutes

Skill training institutes serve as the backbone for workforce readiness and entrepreneurship support. The survey set out to analyze their distribution and effectiveness. *Targeted Institutes: 170,Mapped Institutes: 125*

#### 3. In-Depth Analysis of MSME & Skill Ecosystem

Beyond basic mapping, the study also included in depth analysis, involving qualitative assessments and interviews. For this target was 45 Officials & achievement was 12.

This deeper investigation provided valuable insights into key challenges faced by both MSMEs and skill training institutes, shedding light on policy gaps, infrastructure needs, and financial constraints.

The findings of this survey underscore the importance of targeted interventions in the MSME and skill development sectors. While Tripura has made commendable progress in fostering entrepreneurship and skill enhancement, several areas require further attention. Bridging infrastructure gaps, improving access to finance, and strengthening market linkages are critical to empowering the MSME ecosystem.

### © CELEBRATION OF RASHTRIYA EKTA DIWAS

In observance of "Rashtriya Ekta Diwas", the NIOS Study Centre (AVI- 70001) of VHAT organized a special ceremony on 30th October 2024, with staff & 100 children Anwesha Home to commemorate the birth anniversary of Sardar Vallabhbhai Patel, the Iron Man of India and a symbol of national unity. The event aimed to inspire students and staff with the values of unity, integrity, and patriotism. The ceremony began with an introduction to "RashtriyaEktaDiwas" and a brief overview of Sardar Patel's significant role in unifying India. All attendees participated in the "RashtriyaEktaDiwas" Pledge. Students, faculty, and staff stood together to take the solemn pledge to uphold the unity, integrity, and security of the nation. # **■ INTERNATIONAL BIO-DIVERSITY DAY 2024**

Voluntary health Association of Tripura, observed the 'International Day of Biological Diversity -2024' on  $22^{nd}$  May 2024 with the support of Tripura Biodiversity Board, Agartala. The event was focused on combating invasive species(Parthenium plant) and raising awareness about biodiversity. Fifty volunteers, including VHAT staff , students, local residents, environmental activists and Government Officials participated in the weed removal process from Pandit Nehru Complex & Park .

Awareness campaign was also done through street corner meeting in the side of Nehru Park, to educate the public on the significance of biodiversity, the dangers of invasive species and the role of community action in environmental conservation. The initiative successfully created the targeted areas, allowing for the re-establishing of native species and reducing the allergenic impact of Parthenium on local community.

# ■ E-VEHICLE SURVEY: SURVEY OF ELECTRIC THREE WHEELER VEHICLES FOR FACILITATING ITS INCREASED ADOPTION IN INDIA

The survey was done in collaboration with Barefoot Trust of Shillong, Meghalaya for the purpose to analyze the consumer perspective of electric 3 wheelers for facilitating its increased adoption in India.

**Area of the Survey:** Agartala Municipal Corporation Area, Nagerjala motor stand, Radhanagar motor stand, GB Bazar Stand, Chandrapur ISBT.

#### **Activities done during this Survey:**

- ❖ Eight category surveys have done for the Petrol 3 wheelers, CNG 3 wheelers & Electric 3 wheelers.
- ❖ Total 30 sample survey was conducted in the 4 locations of Agartala Municipal Corporation.
- Cost analysis was done for all the 3 types of vehicles.



#### **Outcome of this Survey:**

- ❖ Majority owners of the petrol & CNG 3 wheelers were very much interested.
- They suggested for the route permit of the Electric 3 wheelers to adopt it widely.
- ❖ It was cost effective, but without route permit it was very tough to control the E-vehicle registration & huge traffic jam was happening at Agartala due to E-vehicles.

### **■ NCPCR STUDY**

National Commission for Protection of Child Rights (NCPCR) a statutory body constituted under section (3) of CPCR Act, 2005 and working under the aegis of Ministry of Women and Child Development, Government of India. This body has the mandate to ensure that all laws, policies, programs, and administrative mechanisms are in consonance with the Child rights perspective as enshrined in the Constitution of India and the UN Convention on the Rights of the Children.

As part of overall well-being of children in India, NCPCR has initiated this significant study titled "To Assess the Implementation of Duties of Teachers and Redressal of Grievances, Pupil-Teacher Ratio and Implementation of Section 28 that Prohibits Teachers from Taking Private Tuitions."

This study is designed to comprehensively evaluate various aspects of the education system, with a focus on teacher performance, grievance resolution mechanisms, Pupil-Teacher Ratio (PTR) compliance, and the enforcement of Section 28 of the RTE Act, 2009. This study was conducted by VHAT with support from Rambhau Mhalgi Prabodhini (RMP), a reputable research organization.

The research involved six primary stakeholders: Students, Parents, Teachers, Principals, School Management Committee/ PTA and Govt. Officers.

#### Area of the study:

To ensure the successful completion of this vital research endeavor, VHAT has been engaged for Tripura (West Tripura and Gomati District) and Arunachal Pradesh (Namsai and Chanlang District) for schools and related FGD.

#### Activities done during this study:

- Six category of survey was done- 1 for students, 1 for parents, 1 for teachers, 1 for principal, 1 for the SMC members & another for the DEO & BEOs.
- ❖ The study was conducted in 2 districts of Tripura & 2 districts of Arunachal Pradesh.
- ❖ The study covers 25 schools in each district- in Tripura 50 Schools & in Arunachal Pradesh 50 schools.
- ❖ Every school covered the survey of 4 students, 4 teachers, 4 parents, 1 principal & 1 SMC member.
- ❖ The study has also covers 8 BEOs, 4 DEOs & 3 FGDs in Tripura & Arunachal Pradesh.

### **■ FLOOD RELIEF RESPONSE BY VHAT**

In August 2024, Tripura experienced a devastating flood, affecting several districts, with South Tripura, Gomati, and Khowai being among the worst hit. In response, the VHAT stepped in to support flood-affected families across the state.

In South Tripura District, VHAT distributed 500 dry ration kits in the following areas: Lawgang, West Charakbai, Kusharghat, Amzadnagar, and Baishnabpur. Similarly, in Sepahijala District, we reached 300 affected families in Rangamura, Grantoli, and East Durlabnarayan.

In addition to food support, VHAT also provided shelter kits to 150 families in Kalyanpur Block of Khowai District, 100 families each in Nalchar and Mohanbhog Blocks Sepahijala of District. These relief efforts were generously supported by Donate Cart, our donor partner for this intervention. Beneficiary selection was based vulnerability, level of flood impact, and verification through field visits and consultation with local panchayats.

In collaboration with Goonj, VHAT also extended relief to 900 families in Gomati District, particularly in the Udaipur Subdivision. The areas covered included Amtali, Hadra, Garjanmura, Jamjuri, Khil Para, Rajdhar Nagar and Udaipur Municipal area. These families received dry ration kits and some shelter materials.

Through these coordinated efforts, VHAT remained committed to providing timely and meaningful support to families in distress.

# REPORT OF MONITORING, EVALUATION & DEVELOPMENT COMMITTEE (EMDC) OF VHAT FOR 2024 - 2025

The EMDC of VHAT was operating under the leadership of Chairperson Mrs. Sikha Saha ,along with other five members. **Main purposes of EMDC** -

- ♠ Strengthening the accountability to the support agencies and the beneficiaries.
- ♠ Allocation of expenditure as per activities.
- ♠ Improvement of performances by strictly adhering to the timeline
- ♠ Find out the gaps in implementation and correcting these.
- ♠ Measuring impact of the performances with key evidences.

This committee had meetings with project staff on regular basis, either in project sites or in the main office during monthly meetings, and half yearly evaluation meeting. They had-

- Interaction with staff, community and direct beneficiaries
- combined half yearly and year end meetings with core project staff
- Verification of project reports submitted by the Project Managers /Coordinators

#### **Observation and findings:**

#### Health promotion-

- In Tobacco Control project, VHAT worked in strong collaboration with State Tobacco Control Cell and District Administration of all eight districts.
- After taking feedback from the participants and the associated Experts, it was strongly felt that activities for Raising awareness on 'Risk Management and Prevention of Antibiotic Resistance' should be continued.
- This year, emphasis was given on the Elderly Care through organizing Health Camps which should be given more importance in the coming years.

#### Education promotion-

- •This year Ratanmani Vidyalay completed 31 years of its glorious existence in providing quality primary education to tribal children of poor tribal families.
- VHAT should take more efforts to increase number of candidates for NIOS courses which were run centrally at Agartala.

#### Child care & protection-

- •Care & other services in the CCIs were as per the guidelines of Mission Vatsalya. CCI staff attended many trainings in and out of the state to enhanced their skill and quality.
- Family based alternative care for the integrated children was extended to Sepahijala district.

#### Welfare of PwDs (Divyangians)--

- All the scheduled activities under SNAC were completed
- With support from Social Welfare and Social Education Department VHAT could successfully run the Half Way Home for 50 cured mentally ill persons. The Modern Psychiatry Hospital extended all the help in health check up of the inmates.
- VHAT had few collaborative works with Shishu Sarothi and Blind Peoples Association & Torchit of Gujrat.

#### Livelihood and skill development --

- JSS Dhalai project fulfilled the targeted activities.
- Integrated Tribal Development project in Kanchanpur was completed this year . New TDF project initiated in Kalyanpur , Khowai district.
- Pig rearing project in North Tripura was initiated with support from Azim Premji Foundation.

#### Shelter Houses for urban homeless extended to four districts.

#### Challenges-

•On time release of the grants was a problem.

#### Recommendations-

- Engagement of technical staff (IT)
- Some of the core staff should be equipped for using more and more modern information technology for better monitoring and documentation of activities keeping space with the current time.
- •More emphasis should be given for developing the competent second line leadership for the organization at least for sustained projects.
